- 1. Call to order / Roll Call / Quorum Determination
- 2. October meeting minutes approved.

- 3. Old or Unfinished Business (Amanda Robinson)
 - Croatan Bridge Rebuild Paperwork is at the City Attorney's office for review. Once it is signed off, it will go to the City Council for approval.
 - Board Elections / Annual Meeting Mike Fantozzi's name was added to the nominee list.
 - CVB Guidelines for Property Responsibility Reviewed the City Code but it doesn't seem helpful for common sense guidance. Mike will work on developing something that it more user friendly.

 - 704 and 708 S. Atlantic reportedly are both for sale.
 - 311 is no longer in existence as the STR complaint line. Use 757-210-5385

 - Texting can also be used especially for domestic or hostage incidents.
 - Smart 911 is on the City website that you can register as much information as you feel comfortable sharing (medical conditions and where you keep meds etc...)
 - City 911 operators are understaffed and overworked. They are looking for new recruits. There are education and physical fitness requirements.
 - If you have cause to call 911 and have a positive experience, please send a note, or call City to give positive feedback.
